 - Discussion and possible action on the proposed IBTC and the Pharr Economic Development Corporation's development initiative titled, the new Pharr Bridge Industrial Center
 - Fred Sandoval, City Manager, City of Pharr gave a brief presentation on Small Area Plans for the City of Pharr and project update.
