Due to inclement weather delays, we shall be extending existing **road closure through May 26, 2023 along South FM494**. Traffic shall be detoured onto Military Highway [FM1016].

Pulice Construction Inc. [prime contractor] shall be constructing proposed drainage improvements.

The Contractor shall cooperate and coordinate with the Engineer and other Contractors working within the limits or adjacent to the project's limits. Designated routes shall be appropriately detoured. #### South FM 494 (Granjeño)


*Underground Infrastructure to Invoke Temporary Closure South FM494, March 20<sup>th</sup> to May 26<sup>th</sup>*




