This will serve as your notice that **a road closure shall take place June 30, 2023 along Las Milpas Road 0.50 miles west of FM2557 (Stewart Road) / 0.30 Miles west of Veterans Road.** This shall impact travel from South Veterans Road to South Stewart Road [depiction].

Pulice Construction Inc. [prime contractor] shall be conducting roadway improvements along Las Milpas.

The Contractor shall cooperate and coordinate with the Engineer and other Contractors working within the limits or adjacent to the project's limits. Designated routes shall be appropriately detoured. The traveling public shall abide all regulatory traffic laws, take reasonable precautions and drive defensively within the construction zones to prevent damage, injury, or loss to the work, materials, and equipment to be incorporated therein, as well as all other property at or on the site.

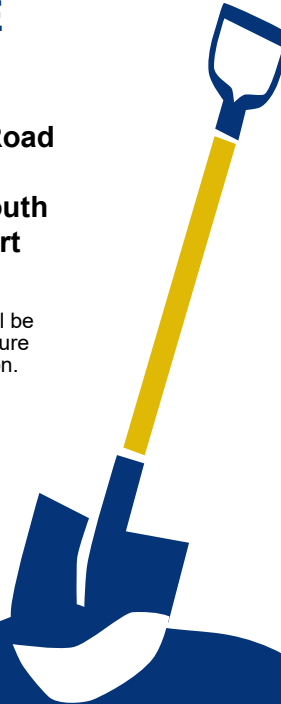

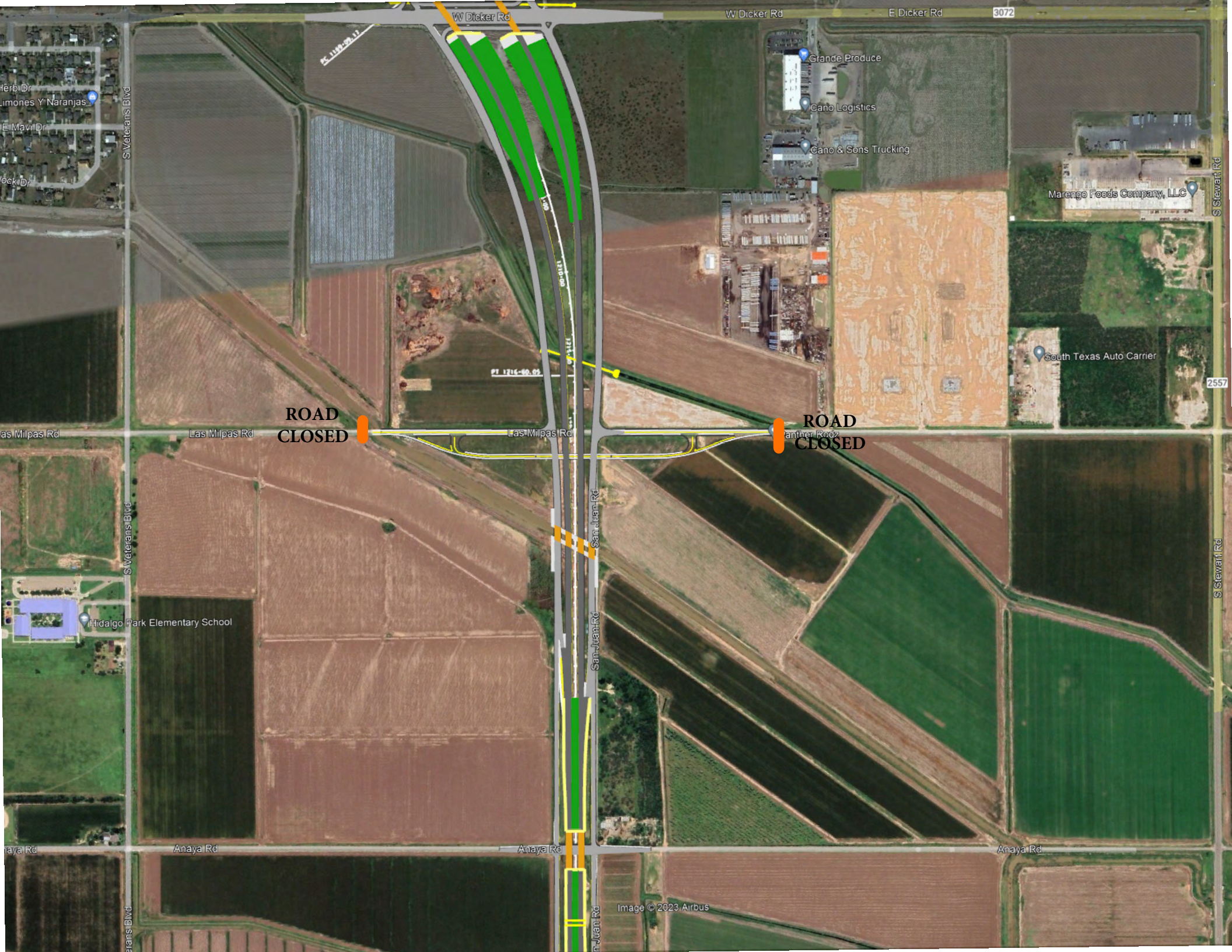

Pulice Construction Inc. [prime contractor] shall be installing proposed overpass bridge sub-structure foundations (drill shafts) at subject intersection.

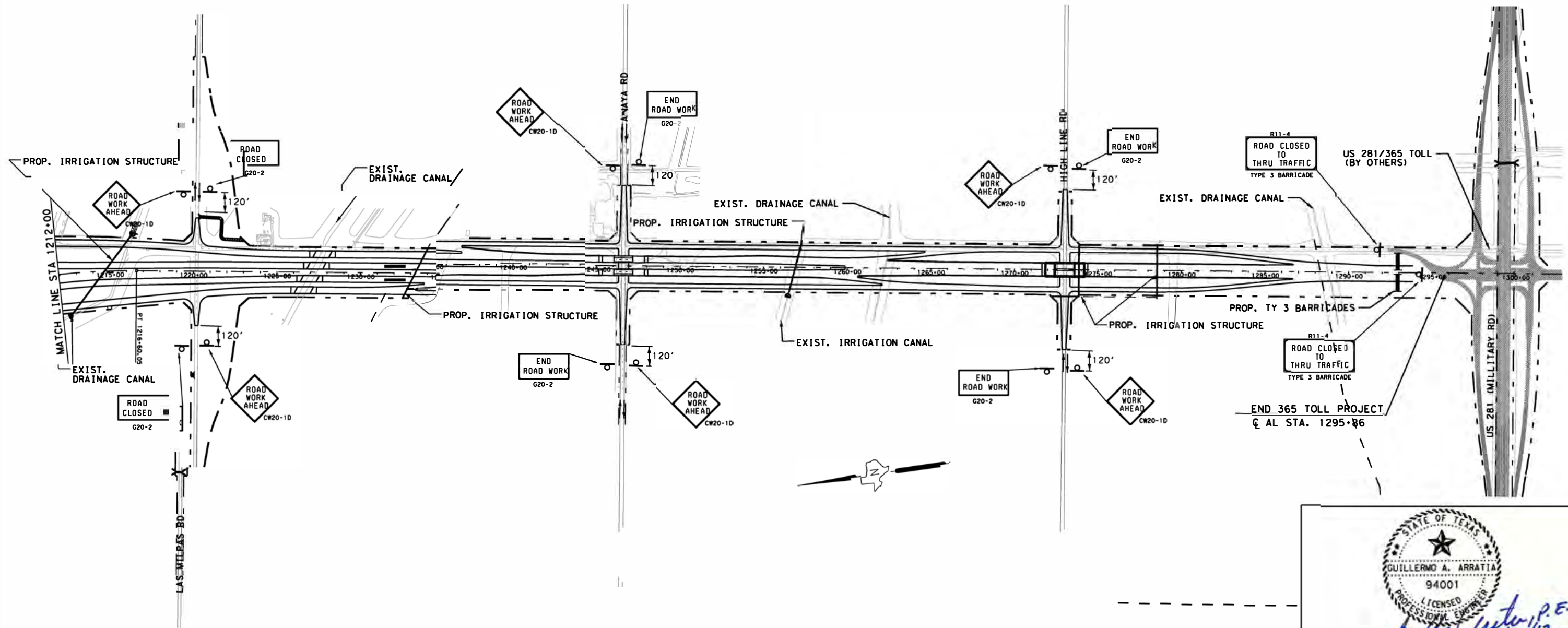

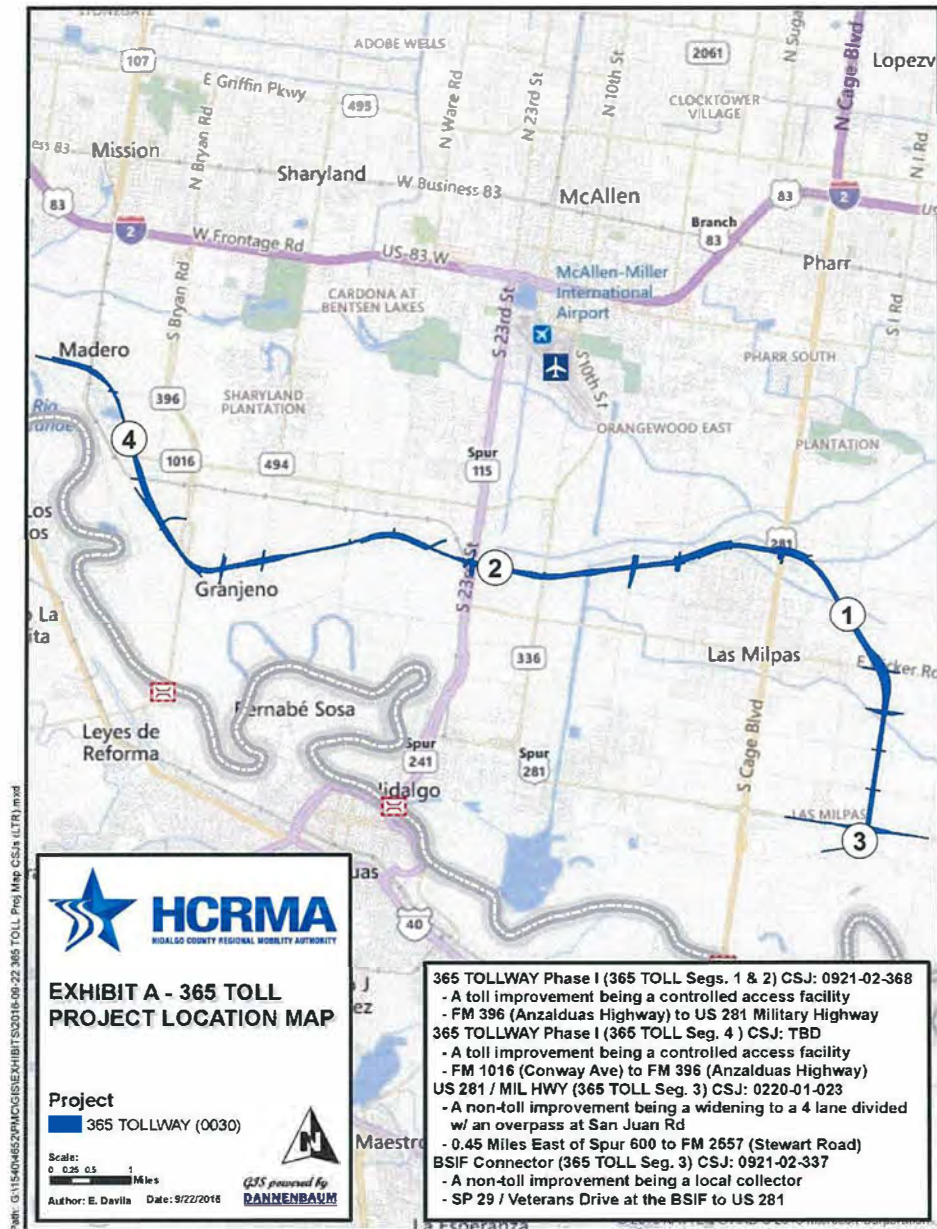

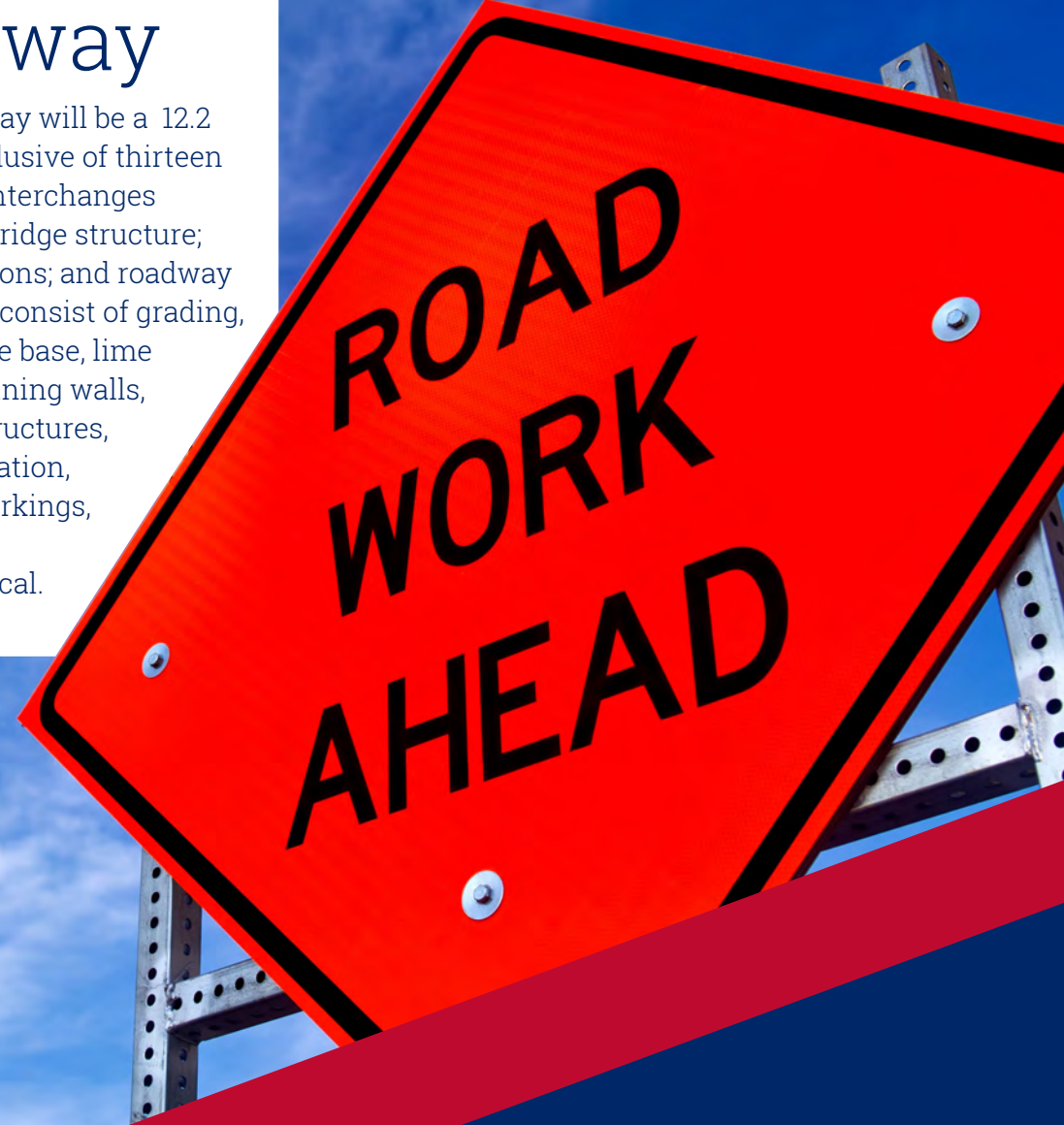

ABOUT 365 Tollway

The HCRMA 365 Tollway will be a 12.2 mile tolled facility inclusive of thirteen (13) grade-separated interchanges and one (1) floodway bridge structure; USIBWC levee relocations; and roadway work. The Project will consist of grading, cement treated flexible base, lime treated subgrade, retaining walls, drainage, irrigation structures, traffic signals, illumination, signing, pavement markings, toll gantries & tolling equipment and electrical.

Production and Performance
